
# THE ACZISC

The ACZISC celebrated its 18<sup>th</sup> anniversary in January 2010. The Committee was established in 1992, following the recommendation of the participants of a Workshop organized by a former agency of the Council of Maritime Premiers and held in Amherst, Nova Scotia. The ACZISC works to foster cooperation in Integrated Coastal and Ocean Management, Coastal Mapping and Geomatics in Atlantic Canada. The ACZISC Strategic Thrusts are included in Appendix 1 (page 20).

### **Operational Context**

Coastal and ocean resources and activities make significant contributions to the economies of the Atlantic Provinces. A selection of studies on the value of these resources is available at http://aczisc.dal.ca/docs.htm.

The coastal zone encompasses a multitude of activities and the management of its resources overlaps several jurisdictions and involves multiple stakeholders. In Atlantic Canada, the coastal land-water interface, *i.e.* the "coastalshed", is exposed increasingly to a wide variety of physical, biological and chemical stresses that threaten the region's economic, social and ecological sustainability. Intergovernmental and inter-agency cooperation is therefore essential for managing the coastal zone, as is access to and the use of information concerning coastalsheds. The ACZISC advocates and facilitates this process.



# **OPERATING STRUCTURE**

The ACZISC Operating Structure consists of four major components: the Atlantic Coastal Zone Information Steering Committee, the ACZISC Association, the ACZISC Advisory Committee and the ACZISC Secretariat. The following schematic describes the Operating Structure:

Membership in the ACZISC is inter-agency, multi-sectoral, and multi-disciplinary. ACZISC represent members governments and organizations which have a mandate for and can contribute to the development, coordination and implementation of ICOM. This includes policy, mechanisms and tools to facilitate access by practitioners to coastalshed data and information.

The ACZISC functions as a 'horizontal mechanism' to implement its mandate. It was used as a case study in two reports published by the Government of Canada to document the challenges of operating successful horizontal and collaborative initiatives and key lessons learned:

### **ACZISC Association**

In November 2003, the ACZISC established the ACZISC Association to act as the legal entity for the ACZISC. The Association is registered as a not-for-profit organization under the Nova Scotia Societies Act. The objects of the Society are listed in Appendix 3 (page 23).

The ACZISC Association Board of Directors is composed of non-government members of the ACZISC Committee. It is chaired by Brent Rowley, EIT Group. The other members of the Board are: Norval Collins, CEF Consultants; Brad Fay, Interpretation Resources Inc; Grant Gardner, Memorial University; and Randy Gillespie, Marine Institute.

Meetings of the Board of Directors were organized and held on 6 May 2009 and on 7 January 2010. The **4**<sup>th</sup> **Annual General Meeting** of the Association was held on 22 January 2009 in Dartmouth, Nova Scotia. The **5**<sup>th</sup> **Annual General Meeting** is being planned for 12 May 2010, also in Dartmouth, Nova Scotia.

### **ACZISC Advisory Committee**

The Advisory Committee was established in 1995 to provide advice on issues related to: the effective administration and operation of the Secretariat and ACZISC; the identification and securement of funding for the Secretariat and ACZISC programs; and the comprehensiveness of ACZISC membership.

The members of the ACZISC Advisory Committee are: Justin Huston, Chair (provincial representative); Grant Gardner (academic representative); Tim Hall (federal representative); Brent Rowley (private sector representative); and Michael Butler (ACZISC Secretariat). The Secretariat communicates with the Advisory Committee on an as-needed basis.

### **ACZISC Secretariat**

The ACZISC Secretariat operates on the basis of a **Memorandum of Understanding** between the ACZISC Committee and the ACZISC Association. The primary **function**, **roles and responsibilities** of the Secretariat are:

- to function as the executing agency for all the decisions of the ACZISC and its bodies and the Association and its Board of Directors
- to convene the meetings of the ACZISC and its bodies
- and to convene the meetings of the Association.

The offices of the ACZISC Secretariat are located in **Ocean House** at 1226 LeMarchant Street in Halifax, Nova Scotia, on the campus of Dalhousie University. The Secretariat is staffed by Michael Butler (Director), Claudette LeBlanc (Project Officer), Jennifer Barr (Finance Officer), and Paul Boudreau (COINAtlantic Project Manager).

In January 2010, Michael Butler and Claudette LeBlanc announced their retirement from the ACZISC Secretariat



retirement from the ACZISC Secretariat effective 31 August 2010. An ACZISC Transition Planning Team was established. The Team met on a number of occasions to consider: ACZISC products and services; the future location of the Secretariat; and a business case and funding model. Recommendations were prepared for presentation to ACZISC members at the 60<sup>th</sup> meeting of the ACZISC scheduled for 12-13 May 2010 in Dartmouth, Nova Scotia.

# **ACTIVITIES IN 2009-2010**

The 2009-2010 ACZISC Workplan was implemented by the Secretariat with the assistance of ACZISC members and associates. As in previous years, the Workplan continued to emphasize information dissemination and networking, primarily via the ACZISC meetings and workshops, the Coastal Update e-newsletter, the ACZISC website and COINAtlantic - the Coastal and Ocean Information Network for Atlantic Canada. The ACZISC also continued to focus on and engage the Integrated Coastal and Ocean Management community of practice in Atlantic Canada.

### **Information Dissemination and Networking**

#### ACZISC Meetings

As in previous years, three ACZISC meetings were held in 2009-2010 in the Atlantic provincial capitals by rotation. The meetings were attended by members and by associates from various sectors, including government departments and agencies, NGOs, academia, community groups and the private sector, and by university students.



The ACZISC meetings were held in Charlottetown, PEI on 13-14 May 2009; in St. John's, NL on 23-24 September 2009; and in Fredericton, NB on 20-21 January 2010.

In addition to the Administration section and the Roundtable Review of Coastal Activities, the ACZISC meetings include focused **presentations with discussions on topics relevant to ICOM, geomatics and coastal mapping**. #### ACZISC Coastal Update e-newsletter

The Coastal Update e-newsletter contains brief items related to ICOM, geomatics and coastal mapping, with links and/or contacts for further information. These items relate to projects and programs; manuals, reports, proceedings; research and development activities; and conferences, workshops and other events.

In 2009-2010, the ACZISC Coastal Update was prepared and emailed each month by the Secretariat to ACZISC members and to more than 5,400 associates. Approximately 75% of the recipients are from Canada and the remainder are from numerous countries worldwide. The distribution list is composed of personnel from all sectors, including: governments at the federal, provincial/territorial/state and local levels; academia; First Nations; the private sector; students and teachers; NGOs; foundations; associations; the media; and international organizations.

#### ACZISC Website

The ACZISC website - http://aczisc.dal.ca - is updated at a minimum of twice weekly. It includes: information about the ACZISC; ACZISC publications; the Coastal Update e-newsletter; a selection of Coastal Resource and Habitat Inventories; and links to other ICOM-related resources.

Planning was initiated in 2009 to merge and enhance the ACZISC and COINAtlantic websites to provide a one-stop online location to support the information needs of ICOM practitioners. A Workshop was organized and held at the Bedford Institute of Oceanography in Dartmouth, Nova Scotia on 26 August, 2009 to consider the development of a strategy, including goals, objectives, user groups, and collaborative

approaches. This was followed by a Workshop held in conjunction with ACZISC Meeting #59 (20-21 January 2010, Fredericton, NB) to consider the convergence of the ACZISC website, COINAtlantic and the information needs of the ICOM community of practice. Another Workshop is being organized for April 2010 to finalize the information content of the website and to review research and development associated with the COINAtlantic search function.

#### COINAtlantic

**COINAtlantic** - the **Coastal and Ocean Information Network for Atlantic Canada** - is an initiative of the ACZISC. The goal is to develop, implement and sustain a network of data providers and users to provide secure access to data, information and applications in support of Integrated Coastal and Ocean Management - for details, see http://COINAtlantic.ca.

In 2009-2010, the **implementation of Phase 1 of the COINAtlantic network was completed**, with the support of ACZISC members and with **financial support from GeoConnections** via a Collaboration Agreement between GeoConnections and the ACZISC Association.



A Joint Project Agreement (JPA) was signed in 2008 between the ACZISC Association and the Oceans, Habitat and Species at Risk Branch of Fisheries and Oceans Canada, Maritimes Region with regard to **staffing for COINAtlantic**. The JPA was extended to 31 March 2010 and Paul Boudreau continued to serve as the COINAtlantic Project Manager; he is based at the ACZISC Secretariat at Dalhousie University.

The following are the major activities that took place in 2009-2010 with regard to the development and implementation of COINAtlantic:

- The ACZISC/GeoConnections Collaboration Agreement concluded as of 30 September 2009.
- Version 2 of the COINAtlantic Web Mapping and Use Tracking Applications were developed, implemented and operationalized. A map gallery was added.
- The identification of resources was initiated for ongoing COINAtlantic operations and project management in 2010-2011.
- A workshop on "The Rights Stuff: Towards a Marine Cadastre for St. Margaret's Bay" was organized and delivered, in collaboration with the University of New Brunswick. The Workshop was held on 6 July 2009 in Lower Tantallon, NS.
- A meeting was organized and delivered, in collaboration with GeoConnections, to discuss Positioning Canada's Information Infrastructure for Effective Watershed, Coastal and Ocean Management. The meeting was held on 16 September 2009 in the offices of Natural Resources Canada in Ottawa, ON.

- COINAtlantic facilitated an international ad hoc Team investigating geospatial search approaches using GoogleEarth.
- COINAtlantic Management Committee meetings were held monthly.
- COINAtlantic Workshops were organized and held on 14 May 2009 in Charlottetown, PEI; and 24 September 2009 in St. John's, NL, in conjunction with the ACZISC meetings.

### **Integrated Coastal and Ocean Management**

The ACZISC ICOM Working Group advocates the implementation of integrated coastal and ocean management (ICOM) in Atlantic Canada. In addition it promotes collaboration with regard to ICOM opportunities and activities, with particular reference to policy issues. In 2009-2010, the ICOM Working Group was co-chaired by Tim Hall, Fisheries and Oceans Canada, Maritimes Region and Justin Huston, NS Dept of Fisheries and Aquaculture.

ICOM Working Group meetings were organized and held on 14 May 2009 in Charlottetown, PEI and 24 Sept 2009 in St. John's, NL in conjunction with the ACZISC meetings.

The ICOM Working Group participated actively in planning to merge and enhance the ACZISC and COINAtlantic websites to provide a one-stop online location to support the information needs of ICOM practitioners.

ICOM Working Group members also participated in activities associated with the ongoing development and implementation of COINAtlantic to **support secure access** to data, information and applications in support of integrated coastal and ocean management ICOM.

### **Activities Generating Revenue for the ACZISC**

The major source of contract revenue for the ACZISC in 2009-2010 was a contract with the IOI-Canada Operational Centre for Michael Butler, the half-time Director of the ACZISC Secretariat, to continue serving as the half-time Director of IOI-Canada. The ACZISC Secretariat is housed in IOI-Canada's facilities at Ocean House on the Dalhousie University campus.

IOI-Canada's primary responsibility is the organization and delivery of the annual **Training Programme on Ocean Governance: Policy, Law and Management** at the University. The 8-week Programme is specifically designed to benefit mid-career professionals from developing countries who are responsible for some aspect of marine management/ocean governance.

The **2009 Training Programme on Ocean Governance** was held from 20 May to 17 July. A wide range of academics, government personnel and practitioners, **including several ACZISC members and associates**, were invited to present on their area of expertise to the participants. The **development of the 2010 Training Programme**, the 30<sup>th</sup> in the series, was initiated. The 2010 Programme is scheduled from 19 May to 16 July - **http://internationaloceaninstitute.dal.ca**.

### **Collaboration with Other Programs**

The participation of the ACZISC Secretariat and Members in the following programs, in executive and other roles, has significantly increased inter-program cooperation and coordination in Atlantic Canada:

#### Bay of Fundy Ecosystem Partnership

BoFEP is a "Virtual Institute" of individuals and groups that **promote the integrity**, **vitality**, **biodiversity and productivity** of the Bay of Fundy Ecosystem, and the **social well-being and economic sustainability** of its coastal communities. BoFEP also facilitates communication and cooperation among interested individuals and organizations. BoFEP celebrated its 15<sup>th</sup> anniversary in 2010 - **http://www.bofep.org**.

The Bay of Fundy Science workshops, organized every two years, are a major BoFEP activity. The **8**<sup>th</sup> **Bay of Fundy Science Workshop** was held on 26-29 May 2009 in Wolfville, NS. The theme for the Workshop was *Resource Development and Its Implications in the Bay of Fundy and Gulf of Maine*. Presentations were made by a number of ACZISC members and the Secretariat staff. The **Workshop Proceedings** are available at http://www.bofep.org/bofep\_workshops.htm.

#### GeoConnections and the CGDI

GeoConnections is a national partnership program established to develop the Canadian Geospatial Data Infrastructure (CGDI). The **CGDI provides Canadians** with on-demand access to geographic information (e.g., maps, satellite images) and related services and applications in support of sound decision making - http://www.cgdi.gc.ca.

The first phase of the GeoConnections program (1999-2005) focused on developing policies, standards, technologies and partnerships. The second phase (2005-2010) supported projects that enable decision-makers to use location-based information to benefit public health, safety and security, the environment, and Aboriginal communities. A proposal is under development to extend the GeoConnections program beyond 2010-2011 but a decision is not expected until the late spring of 2010.

In addition to providing 'direct' financial support for COINAtlantic in 2008-2010, GeoConnections funded a number of initiatives which will **contribute significantly to the information base being accessed by COINAtlantic users** in support of ICOM in Atlantic Canada.

#### Coastal Zone Canada Association

The Coastal Zone Canada Association is a non-profit society of coastal zone management professionals and others interested in and supportive of ICM goals. The CZCA was established in 1993 by members of the ACZISC and other individuals to organize and deliver the inaugural CZC '94 Conference in Halifax and its successor biennial conferences - http://www.czca-azcc.org.

The Coastal Zone Canada 2008 Conference was held on 25-29 May 2008 in Vancouver, BC. Several ACZISC members were in attendance. The Coastal Zone Canada 2010 Conference is scheduled for 25-29 July 2010 in Charlottetown, PEI. The theme is *Healthy Oceans - Strong Coastal Communities: Voices for Change*. Presentations on Conference planning are made on a regular basis at the ACZISC meetings.

#### Gulf of Maine Council on the Marine Environment

The Council is mandated to **protect and conserve coastal and marine habitats** within this bi-national ecosystem, which includes the Bay of Fundy and its watersheds. Membership on the Council includes New Brunswick, Nova Scotia, Maine, Massachusetts and New Hampshire - **http://gulfofmaine.org**.

The **Gulf of Maine Council Action Plan** is based on three overarching, long-range goals: Coastal and marine habitats are in a healthy, productive, and resilient condition; Environmental conditions support ecosystem and human health; and Coastal communities are vibrant and have marine-dependent industries that are healthy and globally competitive. Several ACZISC members are active in the Council Working Group and committees.

#### Ocean Management Research Network

The aim of the Ocean Management Research Network (OMRN) is to create and share knowledge for the application of critical thinking and best practices to oceans management in Canada. Interaction between the natural and social sciences is encouraged. The OMRN is interdisciplinary, providing a forum for researchers, managers, and policymakers to evaluate timely and innovative linkages, integrate lessons learned, transfer and share knowledge, and help create an expert core of ocean researchers - http://www.omrn-rrgo.ca.

The OMRN biennial conferences provide a forum to share ideas and to discuss the current state of knowledge, research gaps and national priorities for the use and management of Canada's three oceans. The **2009 OMRN Conference was held on 21-24 October in Ottawa**, ON. The Conference ended with a recommendation to bring together representatives of ocean networks in Canada in a "summit" in order to discuss mutual interests and opportunities aimed at working more effectively toward delivering oceans awareness, networking and research. A Summit was organized and held on 18-19 March 2010 in Ottawa. A Summit report is forthcoming.

#### Ocean Science and Technology Partnership

The OSTP is an independent, federally incorporated, non-profit corporation developed with the support of Canada's Oceans Action Plan. The mission of the OSTP is: to capture the links between ocean science researchers and technology innovators; to encourage linkages between regional and national networks, information sharing and awareness building; to encourage and support collaboration to build and commercialize technology; and to present a national voice for the ocean technology community - http://www.ostp-psto.ca.

The OSTP and Fisheries and Oceans Canada, through the Canadian Space Agency Government Related Initiatives Program (GRIP), have initiated the development of a Canadian oceans observing systems (OOS) inventory. The project will catalogue each of the subsystems of existing OOS, including information on what is observed; what is being used to observe; how data are modeled or analyzed; what data is being made available to whom and how the information is being maintained, updated, archived and managed.

#### Southern Gulf of St. Lawrence Coalition on Sustainability

The Coalition is a multi-stakeholder regional body representing the Nova Scotia, New Brunswick, Prince Edward Island, and Québec portions of the Southern Gulf of St. Lawrence. The Coalition is working towards an **environmentally, economically and socially sustainable Southern Gulf of St. Lawrence** through a mutually beneficial inter-dependence of these factors. The Coalition celebrated its 10<sup>th</sup> anniversary in 2009 - http://www.coalition-sgsl.ca.

Initiatives in which the Coalition was a participant include: the Community Aquatic Monitoring Program (CAMP); the Coastal Erosion Monitoring project; and the Status of Women Canada project 'Women in Coastal Communities – Using easy tools to better understand finances'. The **Coalition 2009 Annual General Meeting** was held on 11 June 2009 in Emerald, PEI. Sustainability trends, and gaps and issues of the past decade were discussed.
